LVVHS'S MISSION OF REDUCING ANIMAL OVERPOPULATION IS MET THROUGH (1) ITS TRAP-NEUTER-VACCINATE-AND RETURN TO CARETAKER (TNVR) PROGRAM FOR FERAL CATS (THE LARGEST OVERPOPULATION PROBLEM) AT NO COST TO THE CARETAKER AND (2) BY PROVIDING LOW COST/NO COST SPAY AND NEUTERS FOR OWNERS WHO CANNOT AFFORD TO SPAY THEIR CATS AND DOGS. A TOTAL OF 2,584 CATS AND DOGS WERE ALTERED AT LITTLE OR NO CHARGE TO OWNERS AND CARETAKERS THROUGH THESE TWO PROGRAMS. SOME 1,824 OF THESE WERE FERAL CATS SINCE THIS IS THE LARGEST EFFORT FOR LVVHS, AND ANOTHER 446 WERE OWNER'S DOGS AND CATS. IN ADDITION, 314 ABANDONED ANIMALS WERE ALTERED FOR THE LVVHS ADOPTION PROGRAM.

LVVHS PROVIDES A HOTLINE NUMBER WHICH IS ANSWERED BY A PERSON AT LEAST 6 DAYS A WEEK, 8 HOURS A DAY, AND OFTEN 7 DAYS A WEEK. THESE ARE ANIMALS IN DISTRESS THAT ARE FERAL, STRAY, OR ABANDONED. THE FIRST PRIORITY IS ANIMALS WITH INJURIES. THE LVVHS PROVIDES MEDICAL TREATMENT FOR SUCH ANIMALS AS WELL AS REHABILITATION WHEN NECESSARY. FOR THE FISCAL YEAR ENDED JUNE 30,2016 MORE THAN 193 ANIMALS REQUIRED MEDICAL TREATMENT FROM FERAL MALE CATS WITH ABSCESSSES TO BROKEN LEGS ON BOTH CATS AND DOGS. A NUMBER OF THESE ANIMALS HAD TO BE TRAPPED BEFORE TREATMENT COULD BE PROVIDED. THIS ORGANIZATION IS ONE OF A SMALL NUMBER OF AGENCIES OUTSIDE OF ANIMAL CONTROL TRAPPING DOGS.

LVVHS HAS TAKEN ON CATS AND DOGS WITH CRITICAL INJURIES, SUCH AS A FRACTURED PELVIS, OR BROKEN LIMBS WHICH HAVE TO BE AMPUTATED IN SOME CASES. IT PROVIDED ALL THAT WAS NECESSARY FOR THAT ANIMAL'S REHABILITATION FROM THESE SERIOUS INJURIES. THESE ALL TAKE TIME TO MEND AND RESOCIALIZE. ANIMALS ARE SPAYED/NEUTERED/VACCINATED/MICROCHIPPED AND MADE AVAILABLE FOR ADOPTION. FOR THE FISCAL YEAR ENDED JUNE 30,2016, 412 ANIMALS WERE RE-HOMED. LVVHS TAKES BACK ITS ANIMALS IF THEY ARE LATER ABANDONED OR
